Information that we may collect from you

When you visit and enquire about services at www.mer-finswim.co.uk or when booking classes over the phone, email or internet you may be asked to provide certain information about yourself, including your name, contact details, health conditions and - if making an online booking - credit card details. Swimphony Ltd uses a third-party specialist secure card processing provider when taking payments. Mer-Fin Swim Ltd does not hold your card details.

When visiting our website www.mer-finswim.co.uk and completing a contact form your information is held by Wix under their Data protection policy https://support.wix.com/en/article/general-data-protection-regulation-gdpr. A copy of your form is then generated and received by Mer-Fin Swim clerical staff by email to action appropriately, this form is then stored within the email provider software for up to 5 years aligning with GDPR data minimization principles.

The internet is not completely secure. We cannot guarantee the security of your personal data transmitted through our website or by email. Any transmission is at your own risk. Some of the information you provide to us may be considered sensitive personal data as defined by the Data Protection Act 2018 and GDPR. This covers information like your ethnic or racial origin, political opinions, religious beliefs, trade union membership, physical or mental health, sexual life or criminal

record for instance. Mer-Fin Swim Ltd also considers information relating to bank accounts, national insurance numbers, and other unique documents such as passport numbers as sensitive. It is recommended to send such information using a secure system such as encrypted email.
